This is the privacy statement for Eindhovense Studenten Zaalvoetbalvereniging Totelos (hereafter: Totelos or we). This statement is in compliance with Regulation 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of Personal Data and on the free movement of such data (hereafter: GDPR). Becoming a member at Totelos grants Totelos the exhaustive rights concerning personal data as described below. The terms “personal data”, “processing”, “handling” and “data controller” find their definitions in the GDPR and those definitions will also apply in this document.

## Who has access to your data?

The board of Totelos (hereafter: board) has access to all data you provide the association with on the start of your membership. Note that the board changes members every year and this access is passed to consecutive boards. Old board members do not have access to your data. The acting secretary will act as the data controller. Apart from the board no one will have access to your data. The only exception to this rule is the transition period of the boards as the candidate board needs access to the members list in order to get instantiated properly. Note that committees will not receive access to your data without your explicit consent, as you have to supply them with the relevant data yourself.

## What do we save?

Below is an exhaustive list of the personal data we collect and save along with the purpose of the data collection and the grounds on which we collect and save the data. We group the purposes based on the grounds on which we collect and save the data.

#### **Cookies:**

A cookie is a small text file that are sent by certain websites and that are saved on your computer or mobile device. The Totelos website uses cookies to improve your experience when visiting our website. Cookies make sure you stay logged in and remember your language preference. We can monitor the traffic on our website using cookies. Because Totelos only uses strictly necessary and basic analytical cookies (See Article 11.7a (3) of the Dutch Telecommunicatiewet en ePrivacy Verordening) we do not have to ask permission. With this cookie, we save your IP address to see how often you return to our website. This address gets anonymized as soon as possible and no third party has access to this data.
